As per our conversation, there is obviously no medical grade GMP MDMA or psilocybin in Australia at the present time. We are therefore working with a pharmacy group with the required Schedule 8 licences to ensure that these medicines are available to psychiatrists who are authorised prescribers for this purpose from 1 July 2023. I just wanted to understand the TGA's requirements in this area. Are you able to refer me to the appropriate person in the TGA that I can talk to about this.


