Therapeutic Goods Act 1989 Approval under section 42DF for use of restricted representations by

I, Michael Shum, as a delegate of the Secretary to the Department of Health and Aged Care, have approved under section 42DF of the *Therapeutic Goods Act 1989*, the restricted representation described in paragraph (A), for use in advertising the products identified in paragraph (B) to consumers, subject to the conditions identified in paragraph (C).
