### A. THE PARTIES

- 1. The Therapeutic Goods Administration (TGA) forms part of the Department of Health and Aged Care, of which the Applicant is Secretary. Pursuant to s 9A of the *Therapeutic Goods Act 1989* (Cth) (TG Act), the Applicant maintains the Australian Register of Therapeutic Goods (Register), being a register of therapeutic goods for use in humans. Medical devices, as defined by s 41BD(1) of the TG Act, form part of the Register.
- 2. Key Promotional Products Pty Ltd (**Company**) is the first respondent and is the trustee of the C & C Harding Family Trust. Mr Craig Shane Harding is the second respondent and husband of the Company's registered director, Carole Harding. Mr Harding:
  - 2.1. at all relevant times, acted as an agent for or as an employee of the Company in undertaking, directing or managing the relevant conduct outlined below; and
  - 2.2. acted as the directing mind of the Company in relation to that relevant conduct.

# **B. RELEVANT STATUTORY PROVISIONS**

- 3. The Applicant is authorised by s 42Y(1) of the TG Act to apply to the Federal Court of Australia for pecuniary penalty orders in respect of contraventions of civil penalty provisions of the TG Act. Sections 41MIB and 41MLA of the TG Act are civil penalty provisions.
- 4. Section 42YC provides that where a person aids, abets, counsels or procures; induces a contravention, or conspires to contravene a civil penalty provision, the TG Act applies to them as if they had contravened the relevant civil penalty provision.
- 5. The contraventions relate to the alleged import and supply, and representations made about the qualities of, certain rapid antigen test kits (RATs) that were intended to be used for human beings for the purpose of detecting the COVID-19 antigen, and which comprised a specimen collection swab, a solvent for making a solution containing the specimen, and an antigen test cassette for detection of the antigen. Such RATs are 'medical devices' within the meaning of s 41BD(1)(a) the

TG Act because they are an apparatus intended to be used for human beings for the purpose of the diagnosis of disease.

### 6. It is a contravention:

- 6.1. of s 41MIB(1)(a)(i) of the TG Act for a person to import a medical device into Australia; and
- 6.2. of s 41MIB(1)(a)(iii) of the TG Act for a person to supply a medical device in Australia;

unless, pursuant to s 41MIB(1)(b)(i) it is of a kind included in the Register in relation to the person, or another exemption, authority or approval listed in s 41MIB(1)(b)(ia)-(iv) (**Exclusion or Approval**) applies. However, s 41MIB(2) provides that these contravention provisions do not apply if the person proves that they were not the sponsor of the device at the time of the importation or supply.

- 7. Section 41BE of the TG Act deems medical devices to be of the same kind as another medical device if they have the same sponsor. The definition of sponsor in section 3 of the TG Act relevantly includes a person who imports, or arranges the importation of, the goods into Australia, though it does not include people who do so on behalf of another person who is then resident of or carrying on business in Australia.
- 8. From in about December 2021 to March 2022 (**Relevant Period**), there was no Exclusion or Approval in respect of either the import or supply of RATs pursuant to any of ss 41MIB(1)(b)(ia)-(iv) of the TG Act.
- 9. Further, it is a contravention of s 41MLA of the TG Act if a person makes a false or misleading representation that medical devices are of a kind included in the Register.

# C. MEDICAL DEVICES NOT REGISTERED IN RELATION TO THE COMPANY

- 10. No RAT or other medical device is or ever has been included in the Register in relation to the Company.
- 11. During the Relevant Period, there were entries for RATs manufactured under the brand 'Testsealabs' (**TSL Tests**) on the Register, including TSL Tests registered in relation to a company by the name of Pharma Soul Pty Ltd (**Pharma Soul**) as ARTG Entry 373151 (**PS Registration**). However, none of the entries, including the PS Registration, made the TSL Tests imported by the Company of a kind included in the Register in relation to the Company.

# D. IMPORT OF MEDICAL DEVICES NOT ON THE REGISTER

- 12. The Company contracted with L & D Trading Co Ltd (**L & D**), a company based in Hong Kong, to supply and ship RATs to the Company in Australia. The Company's purpose in purchasing the RATs was to sell them to third parties in Australia for profit.
- 13. The Company received invoices from L & D for the supply and shipping of the following amounts of RATs, and paid L & D for those invoices on or about the following dates and in the following amounts:

- 14. The above RATs (**Imported Tests**) originated from China and were shipped to Australia via Hong Kong. The Company retained ICL International Pty Ltd (**ICL**) as its customs broker to manage entry of the RATs into Australia. The Company paid ICL for their services, for GST on the good being imported, and for charges related to the landing of the goods in Australia, in a total sum of no less than \$42,335.11. The Company applied for and secured a permit under the *Biosecurity Act 2015* (Cth) facilitating the import of the Imported Tests (**Biosecurity Permit**).
- 15. On about the following dates, the Imported Tests arrived in Australia by air freight, in the following number of cartons, consigned to the Company pursuant to the following air waybills:

- 16. The Company received the Imported Tests following the landing and customs clearance of each shipment. The Imported Tests were TSL Tests. Some or all of the Imported Tests were accompanied by instructions for use (**IFU**) which recorded them as being for professional diagnostic use only and contained importer details for a Dutch company.
- 17. In the premises of the matters stated in paragraphs 10 to 16 above, the Company imported or arranged the importation of the Imported Tests, being 255,000 RATs comprised in seven individual orders and seven individual shipments. Further, the Company was the *sponsor* of the Imported Tests within the meaning of section 3 of the TG Act and the Imported Tests were not of a kind included in the Register in relation to the Company. Consequently, the Company contravened s 41MIB(1)(a)(i) of the TG Act by importing the Imported Tests.

# E. MR HARDING AIDS AND ABETS IMPORT; CONTRAVENES s 41MIB(1)(a)(i)

- 18. Mr Harding dealt with L & D on behalf of the Company, by email and telephone, in arranging the supply and shipping of the Imported Tests to Australia. Mr Harding made, or alternatively arranged, the payment of L & D's invoices for the supply and shipping of the Imported Tests. Mr Harding oversaw the Company's dealings with ICL. Mr Harding applied for and secured the Biosecurity Permit on behalf of the Company. The air waybills for the shipment of the Imported Tests to Australia were directed for the attention of Mr Harding. Mr Harding was further responsible for the day-to-day running of the Company.
- 19. Mr Harding knew that the Imported Tests were not a kind included in the Register in relation to the Company. Further, as a result of the following emails, it must be inferred that by no later than on or about 4 January 2022, Mr Harding was aware that the Imported Tests were required to be included in the Register in relation to the Company:
  - 19.1. an email dated 4 January 2022 from 'Carrie' from Guangzhou Bomeirui Manufacturing Co Ltd, which stated that import of RATs into Australia requires a "TGA Certificate" issued to the Company, meaning inclusion in the Register in relation to the Company;
  - 19.2. an email dated 20 January 2022 from Stephanie Golman of Pharma Soul to Mr Harding, in which he was informed that it was "illegal to import and sell" the TSL Tests in Australia because they were neither approved by the TGA nor "approved by Pharma Soul for import"; and
  - 19.3. an email dated 22 January 2022 from <a href="mailto:sales@testsealabs.com">sales@testsealabs.com</a> to Mr Harding in response to his request for a manufacturer's certificate, in which he was advised that "Australia market [sic] is special, you can not import illegally".
- 20. Despite this, Mr Harding continued to import the TSL Tests, noting in emails of 6 and 7 January 2022 that the Company sought a Biosecurity Permit for RATs that were "NOT ARTG approved", meaning not of a kind included in the Register in relation to the Company.
- 21. In the premises, Mr Harding intentionally assisted the Company to import the Imported Tests into Australia, and aided and abetted or procured the contraventions of s 41MIB(1)(a)(i) of the TG Act. Pursuant to s 42YC and 42Y, he is liable for a pecuniary penalty for those contraventions.

# F. SALE OF TESTS: COMPANY CONTRAVENTION AND MR HARDING'S INVOLVEMENT

22. The Company by its agent or employee Mr Harding sent emails offering the Imported Tests for sale on the dates and times, and to the number of recipients recorded in Annexure A. Upon receiving responses, the Company invoiced the relevant recipient for the number of Imported Tests ordered in the amounts recorded in Annexure B. The relevant recipients paid the Company in the

- amounts and on the dates also recorded in Annexure B. Following payment and the receipt of the Imported Tests, the Company delivered the tests that had been ordered.
- 23. In the premises, the Company supplied not less than 240,720 Imported Tests within Australia by way of sale. As the Imported Tests were not of a kind included in the Register in relation to the Company, each of those supplies by the Company contravened s 41MIB(1)(a)(iii) of the TG Act. As the Company was the sponsor of those Imported Tests, s 41MIB(2) did not apply.
- 24. Mr Harding was involved in the supply in that he offered the Imported Tests for sale on behalf of the Company and managed the Company in receiving the orders and payment for those RATs, and in distributing them. Mr Harding was further responsible for the day to day running of the Company. He knew the matters referred to in paragraph 19 above. Consequently, Mr Harding intentionally assisted the Company to supply the Imported Tests in Australia, and aided and abetted or procured the contraventions of s 41MIB(1)(a)(iii) of the TG Act. Pursuant to ss 42YC and 42Y he is liable for a pecuniary penalty for those contraventions.

# G. FALSE OR MISLEADING REPRESENTATIONS, COMPANY CONTRAVENTION, AND MR HARDING'S INVOLVEMENT

- 25. The Company, by Mr Harding, sent emails offering the Imported Tests for sale on the dates and at the times, to the number of recipients recorded in Annexure A. Each email in Annexure A is a representation to the recipient and, where there are multiple recipients, is a representation to each of these recipients that the Imported Tests offered for sale were able to be supplied pursuant to the PS Registration or alternatively some other registration of RATs on the Register. Consequently, they were representations that the Imported Tests offered for sale were of a kind included in the Register for the purposes of s 41MLA of the TG Act. The representation arose from the use of the words "TGA Approved" or "TGA Approval", and, further or alternatively, by attachment of a record of the PS Registration to each email.
- 26. The said representations were false or misleading in that they were made in respect of Imported Tests being imported into Australia and supplied by the Company as the sponsor. The importation of the Imported Tests by the Company meant that they were not able to be supplied pursuant to the PS Registration or any other registration, were not of the kind included on the Register pursuant to the PS Registration or any other registration, and were consequently not "TGA approved".
- 27. Mr Harding was involved in the misleading and deceptive representations in that he made those representations. Mr Harding was further responsible for the day to day running of the Company. He knew the matters referred to in paragraph 19 above and consequently knew at all times or alternatively by no later than 4 January 2022 or further alternatively by no later than 22 January 2022 that the representations were false or misleading. Consequently, Mr Harding intentionally assisted the Company to make the misleading and deceptive representations, and aided and abetted or procured the contraventions of s 41MLA of the TG Act. Pursuant to s 42YC and 42Y he is liable for a pecuniary penalty for those contraventions.

# H. RELIEF, AND PRIMARY GROUNDS SUPPORTING SUCH RELIEF

28. The Applicant seeks the relief against the first and second respondents set out in the accompanying Originating Application comprising declarations pursuant to s 21 of the *Federal Court of Australia Act 1976* (Cth) (**FCA Act**), pecuniary penalties pursuant to s 42Y of the TG Act, and costs under s 43 of the FCA Act.

- 29. By reason of the matters set out in paragraphs 12 to 17 above, by each shipment of TSL Tests imported into Australia, the Company contravened s 41MIB(1)(a)(i) of the TG Act. By reason of the matters set out at paragraphs 18 to 22 above, Mr Harding aided, abetted, counselled or procured the Company's contravention of s 41MIB(1)(a)(i) of the TG Act and, by reason of that conduct, contravened s 42YC(1) of the TG Act.
- 30. By reason of the matters set out at paragraphs 22 to 24 above, each time that the Company made a supply of Imported Tests, the Company contravened s 41MIB(1)(a)(iii) of the TG Act. By reason of the matters set out at paragraph 24 above, Mr Harding aided, abetted, counselled or procured the Company's contravention of s 41MIB(1)(a)(iii) of the TG Act and, by reason of that conduct, contravened s 42YC(1) of the TG Act.
- 31. By reason of the matters set out at paragraphs 25 to 26 above, each time the Company made a representation that the TSL RATs were included on the Register, the Company contravened s 41MLA of the TG Act. By reason of the matters set out at paragraph 27 above, Mr Harding aided, abetted, counselled or procured the Company's contravention of s 41MLA of the TG Act and, by reason of that conduct, contravened s 42YC(1) of the TG Act.

#### I. ALLEGED HARM

- 32. One of the objects of the TG Act, by s 4(1), is to provide for the establishment and maintenance of a national system of controls relating to the quality, safety, efficacy and timely availability of therapeutic goods (including medical devices) that are used in Australia. This is achieved through a general requirement that therapeutic goods imported and supplied in Australia be entered on the Register. RATs are only approved and entered on the Register if the TGA is satisfied that the minimum performance requirements are met for the relevant medical device.
- 33. The Imported Tests were not assessed or approved within the regulatory framework. This means that their quality, safety and performance has not been established. The Company put the health and safety of consumers in Australia at risk from potentially defective or substandard RATs, or RATs which contained inadequate instructions for their use and were not suitable for self-testing. The Company also undermined the integrity of the regulation of therapeutic goods in Australia. By importing and supplying the Imported Tests to pharmacies and retail outlets, the Company created risks of harm to end users of the Imported Tests and the public by:
  - 33.1. as a result of receiving false negative test results, unknowingly contributing to the transmission of COVID-19 infections within Australia by failing to isolate or take other transmission reduction steps when infectious, and failing to access important health information relevant to Australians to help them manage their illness; and
  - 33.2. as a result of receiving false positive test results, unnecessarily causing members of the public, including critical workers and their families, to isolate and creating unnecessary strain on households, businesses and essential services.
- 34. The false or misleading representations made in offering the Imported Tests for sale to medical professionals, pharmacies and retail outlets further extended the risk of harm from preceding contraventions by misleading customers into use or retail sale of the Imported Tests in the belief that they had been assessed and approved by the TGA.
