Strongly support

- The Australasian College of Sport and Exercise Physicians (ACSEP) strongly support the proposed regulatory changes as it will provide increased clarity for athletes, Medical Practitioners and active Australians who choose to use supplements about the regulatory framework for Sports Supplements.
- There are a number of studies demonstrating the presence of World Anti-Doping Agency (WADA) Prohibited Substances and Scheduled Poisons in sports supplements available for sale in Australia. ACSEP feels that increased regulation of sports supplements will reduce the risk of an Anti-Doping Rule Violation (ADRV) for athletes. Removing substances that are harmful to health with also protect the health of active community members and that of the broader Australian population.
- Any clarity around sports supplements regulation will reduce the administrative burden of athletes and sports in Australia and as members of the sporting landscape, the members of the ACSEp

Somewhat positive

- ACSEP believe that the proposed declaration would have a 'somewhat positive' impact on the availability and choice of sports supplements for athletes.
- Athletes will still have access to a wide variety of sports supplements that are of a higher quality due to the declaration.
- ACSEP would welcome increased regulation and post market testing of supplements to
 ensure compliance with TGA requirements and further reduce the risk to athletes and
 members of the sporting public of poisons or WADA code banned substances.
