#### Upcoming sponsor communication on the proposed new annual charge exemption scheme (ACE)

# Good morning/afternoon

In April 2014 we <u>released a consultation paper</u> as part of a review of the low value turnover (LVT) annual charge exemption scheme. From the review findings, we developed a <u>Regulation Impact Statement (RIS)</u>. This has been endorsed by the Assistant Minister for Health and is available on the TGA website. The RIS outlines a proposed new exemption scheme which, if implemented, will replace the LVT scheme.

# Annual charge exemption (ACE) scheme

The proposed annual charge exemption (ACE) scheme will commence on 1 July 2015 if the Federal Executive Council approves the amendment of the regulations in one of its meetings before 1 July 2015. Information about the <u>proposed ACE scheme</u> is available on the TGA website.

## **Pre-qualified entries**

Under the new scheme all new entries in the Australian Register of Therapeutic Goods (ARTG) on or after 1 July 2015 would automatically qualify for an ACE until the entry first generates turnover. Existing entries in the ARTG at 30 June 2015 would qualify for exemptions in 2015-16 if they had been granted LVT exemptions in 2013-14 and 2014-15 and had \$0 turnover in those years.

Based on the information submitted by you when seeking LVT exemptions in 2013-14 and/or 2014-15, we have identified those entries on the ARTG that would pre-qualify for an ACE in 2015-16, using the following criteria:

The product:

- was entered in the ARTG in 2013–14 or earlier, you applied for and were granted LVT exemptions for 2013–14 and 2014–15, and your product had \$0 turnover in 2013–14 which was certified by a third party accountant; or
- was entered in the ARTG between 1 July 2014 and 30 April 2015, you applied for and were granted an LVT exemption on the estimated turnover for 2014–15.

In addition, all entries first entered in the ARTG in May or June 2015 would prequalify without any action on your part.

If you have a pre-qualified ARTG entry, you will receive a letter in June 2015 from the TGA advising which of your ARTG entries pre-qualifies for an ACE exemption. If you believe you have entries that qualify for ACE and do not receive a letter by 12 June 2015, please notify us by email <u>ace.scheme@tga.gov.au</u>.

## Information sessions
