Points:

We are not hiking up fees. In fact annual charges for medical devices class IIa and above will reduce by 5% under the new scheme.

We are expecting revenue will decrease not increase as a result of these changes, as there is no additional annual charge revenue planned for and LVT application fees of \$2.4m will be abolished.

As you know fees and charges are not a part of the regulatory costing under the OBPR framework – our RIS follows the OBPR framework.

As this scheme eliminates the current cross subsidisation between sponsors some sponsors will pay more overall to bring equity back to the system, however this is significantly offset by reductions in rates.

Mr Williams makes no suggestions for the structure of annual charges or how an exemption scheme should operate (if he believes one appropriate).

Philippa has confirmed with Will that we've noted the ADIA objection in our MinSub. Please let me know if I need to take any action I might not think of.

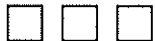

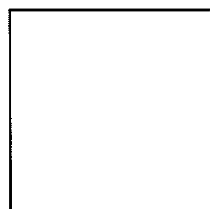
