ANTISERUM REAGENT – A/Brisbane/1/2018 FOR SINGLE RADIAL IMMUNODIFFUSION (SRID) ASSAY OF INFLUENZA VIRUS HAEMAGGLUTININ

TGA Lot: AS428 (DOM: November 2018)

1. Introduction

Influenza antiserum reagent TGA Lot AS428 is prepared for single radial Immunodiffusion (SRID) assay of A/Brisbane/1/2018 (A/Switzerland/8060/2017-like) antigens.

2. Unitage

No unitage is assigned to this material.

3. Contents

Country of origin of biological material: Australia **Animal Species:** Domestic sheep (*Ovis aries*) **Donor Sheep Breed:** Australian Merino Cross

The sheep originated, were continuously reared and slaughtered in Australia.

The purified haemagglutinin (HA) used to immunise sheep was derived from a beta-propiolactione (β PL) inactivated pool of A/Brisbane/1/2018 (X-311) virus. The HA was purified using a protease treatment step prior to further downstream purification. All sheep used in the production of antisera were inspected by a veterinary surgeon prior to terminal bleed to confirm their disease free status. The antiserum contains 0.1% sodium azide as preservative.

4. Caution

THIS PREPARATION IS NOT FOR ADMINISTRATION TO HUMANS.

The preparation does not contain material of human origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures probably will include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.



5. Use of material

For SRID testing of influenza virus antigens; this antiserum is suitable for the testing of A/Brisbane/1/2018 antigens. For the TGA antigen A/Brisbane/1/2018 (X-311) Lot 2018/125B containing approximately 20-30 μg HA per mL, add 1.5 μL of the undiluted antiserum to 1 mL of agarose. It may be necessary to change the antiserum concentration according to local laboratory conditions.

Antiserum reagent AS428 should be used according to the method described by Wood, JM, Schild, GC, Newman, RW, and Seagroatt, VA, Journal of Biological Standardisation, 1977, 5, 237-247.

6. Stability

It is the policy of WHO not to assign an expiry date to their international reference materials. Reference Materials should be stored on receipt as indicated on the label.
