## **Notification of turnover**

Annual Charge Exemption (ACE)



#### Please note:

Making a notification of turnover advises the TGA to issue the sponsor with an annual charge invoice in respect of a notified ARTG entry.

The *Therapeutic Goods Regulations 1990* provides an exemption from paying the annual charge for a good (excluding export only) that is registered, listed or included in the Australian Register of Therapeutic Goods (ARTG) until the ARTG entry commences generating turnover.

Once an ARTG entry commences generating turnover, **the exemption ceases.** The annual charge in respect of that ARTG entry will become payable for the financial year in which turnover is notified as having commenced and each financial year thereafter, up to and including the financial year in which the entry is cancelled from the ARTG, even if the entry has not generated turnover in a future financial year.

The annual charge invoice will be issued at the end of the month in which the notification is made. The date for payment of the annual charge invoice will be no later than the last day of the first month after the month in which notification of turnover was made.

The completed and signed declaration form must be submitted to the TGA by email to <a href="mailto:ace.scheme@health.gov.au">ace.scheme@health.gov.au</a>. Please ensure the 'tracking' settings on your email account are set to request a "delivery receipt" and/or "read receipt".
